The Florida Department of Economic Opportunities (DEO) has awarded a Community Development Block Grant in the Housing Rehabilitation Category to Suwannee County, FL. These grant funds will be utilized to repair or replace approximately eleven (11) low to moderate income owner occupied homes within Unincorporated Suwannee County, Florida.

If your home is in need of repair and you would like to apply to receive grant funding Suwannee County will be accepting pre-application packages thru September 15, 2017 at 4:00 PM.

Completed pre-application packages must be received at the Suwannee County Administrator's Office by **4:00 P.M. on Friday, September 15, 2017**. Pre-Application packages received after the deadline date and time will only be considered as alternates if remaining funds are still available.
